

**IMPORTANT PLEASE READ**  
***SIGNATURE AND DECLARATION OF VALUE REQUIRED***

Personal effects and household goods include those used items such as clothing, furniture, appliances, books, and other miscellaneous items found in the normal household. These items must be securely packed and protected to insure safe transit.

Please be advised that in the event of loss or damage the carrier's liability (Honolulu Freight Service) is strictly limited when shipping personal effects and household goods. As a result, you, the shipper, must declare in writing the value of your goods. This value, the released value, is not specific to each nor is it related to the original cost of the items. It is an arbitrary amount you place on the items to used in the unlikely event of loss or damage. Honolulu Freight Service may be liable for no more than the amount claimed by you, the shipper, to be the released value - set on a per pound, per article basis.

The released value of items varies according to the value expressed by you, the shipper, for those items. As the Honolulu Freight Service's liability increases - so does the cost of transport.

The released value on these articles are covered in Honolulu Freight Service Tariff 267, Item 5080, 60604 199, as follows:

___	Released to a value not exceeding	\$ .10 per LB	= 4.55 per cubic foot
___	Released to a value between	\$ .10 per LB and \$ .20 per LB	= 4.70 per cubic foot
___	Released to a value between	\$ .20 per LB and \$ .50 per LB	= 5.04 per cubic foot
___	Released to a value between	\$ .50 per LB and \$2.00 per LB	= 5.68 per cubic foot
___	Released to a value between	\$2.00 per LB and \$5.00 per LB	= 7.88 per cubic foot

Be advised: \*Shipments valued at more than \$5.00 per pound **WILL NOT BE ACCEPTED**.  
\*Articles of unusual value - jewelry, precious stones, precious metals, money, works of art, and antiques **WILL NOT BE ACCEPTED**.

Be advised that this coverage is not insurance. In order to have complete coverage for full value, we recommend that you contact your insurance agent or broker. Honolulu Freight Service does not offer this type of insurance.

In an attempt to reduce your freight costs and still be paid the full value of your shipment, in the event of a loss or damage, we strongly recommend that you provide your own transportation insurance and choose the lowest level of coverage and the lowest rate.
