Any charges not paid within 45 days of the date of billing may be assessed interest charges computed from the billing date to the date of payment at the highest rate permitted by the applicable laws.

Applicant guarantees payment to HFS for all charges due. If applicant makes payment for HFS' charges to a broker or agent instead of directly to HFS and such broker or agent for any reason fails to pay such charges to HFS, applicant remains unconditionally liable to HFS for payment of all such charges. Furthermore, applicant understands that no offsets, contra-settlements, discounts or any others deductions from HFS' charges are permitted.

If it becomes necessary for HFS to place applicant's account with an outside agency for collection, applicant agrees to pay HFS' costs of collection in addition to the freight and accessorial charges due. If it further becomes necessary to place applicant's account with an attorney for collection, applicant also agrees to pay such additional sums as the Court or arbitrator may adjudge as reasonable attorney's fees and costs of litigation.

All services performed by HFS for applicant are subject to the rules and regulations set forth in HFS' current tariff circular, a copy of which is available to applicant upon request, and the terms of which are subject to revision by written notice to the applicant.
